Narrative

During an alcohol compliance check, the underage agent went inside this location to attempt to purchase an alcoholic beverage. The underage went to the cooler section of the store, picked an alcoholic beverage and carried it to the register where he was able to make the purchase.

The underage met me outside where I took possession of the alcohol. I returned the alcohol and change to the store; I retrieved my marked twenty-dollar bill. I wrote the offender a citation for selling alcohol to a minor.

Supplement

On 6/24/2024, I, P.S.A. D. Papageorge, assisted Officer S. Luther with an alcohol compliance check.

At approximately 1654 hours, I entered Bottle Shop, 2774 Cobb Pkwy, and while being under the age of 21, was able to complete the purchase of 1 case of White Claw. The employee, later identified as Inez Alston, charged me \$10.59. I completed the purchase by using one of the three \$20 bills that Officer S. Luther provided for this purpose. I left the business with the alcoholic beverages, receipt from the purchase, and the monetary change left over from the transaction.

I immediately met with Officer S. Luther in the business parking lot and turned over the left-over change from the transaction \$9.49, the receipt and the alcoholic beverages I purchased.

Officer S. Luther took these items and went back inside to the business to take law enforcement action.
