Dear Licensee:

The City of Kennesaw Police Department performed a massage compliance check on May 15, 2023, at Lavender Relax Spa Inc. dba Sunshine Massage located at 2790 Cobb Pkwy, Kennesaw, Ga 30152. On the day of the massage compliance check, a Kennesaw Police Officer went inside the business and asked to see a copy of the State issued massage therapy license for every massage therapist working at that time. The one employee working during the compliance check was unable to provide a State issued license or provisional permit. The Officer then asked to see the record of treatment. The sign-in sheet was barely legible and appeared to be first names only. In addition, the employee working was not registered with the Business License office. Due to the violations stated above, The Kennesaw Police Department cited your business on May 17, 2023, for information concerning employees to be filed with the Business License Department, a record of treatment to be maintained, and massage by an unlicensed person. According to the provisions of the City of Kennesaw Massage Therapy Business Code:

1. Section 22-224, in part:
Within three business days of commencement of operations of the business, the applicant shall file with the business license department an affidavit stating the names of all employees. After hiring each new employee and prior to that employee's commencement of employment, the applicant shall provide the name of each such prospective employee and the documentation, to the business license department for a background investigation as set forth in the Kennesaw Code of Ordinances, section 22-9.

Massages may be given by persons not holding a license as a massage therapist only in accordance with O.C.G.A. § 43-24A-9, as may be amended from time to time.

The Kennesaw License Review Board will hold an appeal hearing to hear the charges and specifications against you, and your responses, if any, will be read into the record. The License Review Board will make a determination regarding the status of your license at the hearing.

CHARGES AND SPECIFICATIONS

A HEARING WILL OCCUR BEFORE THE LICENSE REVIEW BOARD ON THURSDAY, JUNE 20, 2023 AT 2:00 P.M. RELATIVE TO LAVENDER RELAX SPA INC. AND LICENSEE QIONG LIANG LOCATED AT 2839 CHEROKEE STREET, SUITE D, KENNESAW, COBB COUNTY, GEORGIA 30144.

Pursuant to the City of Kennesaw Ordinances Section 22-221, a hearing will be held by the License Review Board to determine whether or not the City of Kennesaw Massage Therapy Business License for Lavender Relax Spa Inc. and licensee, Qiong Liang located at 2839 Cherokee Street, Suite D, Kennesaw, Georgia 30144 should be suspended or revoked.

The alleged circumstances necessitating the hearing are as follows:

1. The incident, which forms the basis of the hearing, is the City of Kennesaw Police Department performed a massage compliance check on May 15, 2023, at Lavender Relax Spa Inc. dba Sunshine Massage located at 2790 Cobb Pkwy, Kennesaw, Ga 30152. On the day of the massage compliance check, a Kennesaw Police Officer went inside the business and asked to see a copy of the State issued massage therapy license for every massage therapist working at that time. The one employee working during the compliance check was unable to provide a State issued license or provisional permit. The Officer then asked to see the record of treatment. The sign-in sheet was barely legible and appeared to be first names only. In addition, the employee working was not registered with the Business License office. Section 22-224 "within three business days of commencement of operations of the business, the applicant shall file with the business license department an affidavit stating the names of all employees, After hiring each new employee and prior to that employee's commencement of employment, the applicant shall provide the name of each such prospective employees and the documentation, to the business license department for a background investigation as set forth in the Kennesaw Code of Ordinances, Section 22-9." 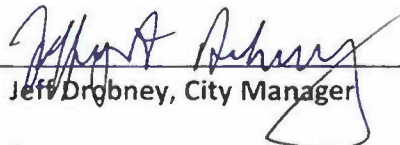

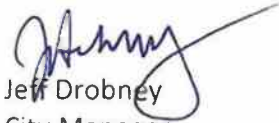

CHARGES AND SPECIFICATIONS

A HEARING WILL OCCUR BEFORE THE LICENSE REVIEW BOARD ON TUESDAY, JUNE 20, 2023 AT 2:00 P.M. RELATIVE TO LI DONG THERAPY LLC AND LICENSEE LI WANG LOCATED AT 2790 COBB PARKWAY, KENNESAW, COBB COUNTY, GEORGIA 30152.

Pursuant to the City of Kennesaw Ordinances Section 22-221, a hearing will be held by the License Review Board to determine whether or not the City of Kennesaw Massage Therapy Business License for Li Dong Therapy LLC and licensee, Li Wang located at 2790 Cobb Pkwy, Kennesaw, Georgia 30152 should be suspended or revoked.

The alleged circumstances necessitating the hearing are as follows:

1. The incident, which forms the basis of the hearing, is the City of Kennesaw Police Department performed a massage compliance check on May 15, 2023, at Li Dong Therapy LLC dba Lu's Massage located at 2790 Cobb Pkwy, Kennesaw, GA 30152. On the day of the massage compliance check, a Kennesaw Police Officer went inside the business and asked to see a copy of the record of treatment. The sign-in sheet given to the Officer had a few first names, scribbled lines, and phone numbers. The Officer then asked all three employees for a copy of their State issued massage license and two out of the three employees provided the Officer with a copy of their State license. The third employee, who was unable to provide the Officer with a copy of their State massage license, was seen by the Kennesaw Police Officer coming out of a room with a customer and the customer tipped the employee for the massage services received. The third employee was not registered with the Business License office. Section 22-224 "within three business days of commencement of operations of the business, the applicant shall file with the business license department an affidavit stating the names of all employees, After hiring each new employee and prior to that employee's commencement of employment, the applicant shall provide the name of each such prospective employees and the documentation, to the business license department for a background investigation as set forth in the Kennesaw Code of Ordinances, Section 22-9." Section 22-225 "it shall be the duty of any person granted a business license under this article to maintain correct and accurate records of the names and addresses of the persons receiving treatment at such establishment, the type of treatment administered,

and the name of the person at the establishment administering such treatment.”

Section 22-228 “massages may be given by persons not holding a license as a massage therapist only in accordance with O.C.G.A 43-24A-9, as may be amended from time to time.”

2. The witnesses that may be called at said hearing are the following: Licensee, Li Wang; Kennesaw Officer, Scott Luther.
3. Documentary or physical evidence that may be tendered at the said hearing are as follows: Massage License for Li Dong Therapy LLC; Police bodycam footage; Citations; photos of the record of treatment.

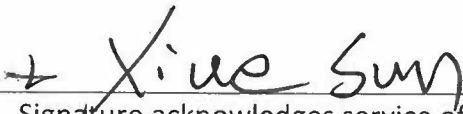

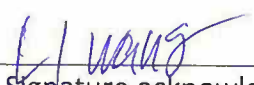

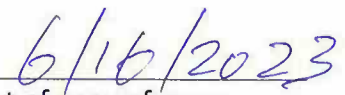
